

Early Years Pupil Premium Voluntary Registration

From April 2015 all early years providers who deliver Government funded early education will be able to claim the early years pupil premium for 3 and 4 year old children whose parents are in receipt of one or more benefits, tax credits or circumstances.

Registering could provide up to an extra £300 for your child's nursery, pre-school or child minder to fund valuable support like extra training or, resources to help raise the quality of your child's early education.

The information you provide in this form will be used by the council to confirm receipt of one of the listed welfare benefits. They will do this by checking out work benefit data provided by HMRC and DWP.

Once this is confirmed, we can decide how much money your child's nursery, child minder or pre-school will receive.

You are free to withdraw your consent so that your details are not used in future.

Whether you use this scheme or not, it will not affect any of the benefits you may be entitled to.
